

Spectators Conditions of Entry

Overview

All patrons who enter a venue used by the Bendigo Amateur Soccer League are deemed to have acknowledged and accepted these Conditions of Entry:

- 1) All persons' movements upon entering any Club Venue may be subject to monitoring by closed circuit television or other recording or photographic device, and any footage and/or images taken may be provided to FV who may provide such information to the responsible authorities (eg Victoria Police, FFA, and any other stakeholder at FV's absolute discretion) and by entering the Club Venue a patron shall be deemed to have given consent to such monitoring and provision of such footage or images in accordance with this clause.
- 2) Persons entering the playing area without authorization will be ejected from the Club Venue and may be prosecuted or banned from future matches in accordance with FV policy.
- 3) Patrons should be aware that sporting equipment such as footballs may be kicked or struck from the playing field into the seating, standing areas or car parking areas during events at any time.
- 4) Patrons choosing to leave valuables at the venue do so at their own risk and neither the Club, FV nor the venue management shall be responsible for any damage to or loss or theft of a patron's personal property.
- 5) All patrons may be subject to bag searches, pat downs, and electronic scanning before entering the Club Venue and any items not permitted to be brought into the Club Venue may be confiscated by venue staff.
- 6) Patrons are not permitted to bring the following items into Club Venues:
 - (a) alcohol or illicit drugs
 - **(b)** flares, knives or offensive weapons, laser lights or anything that may be a potential missile or potentially cause a disturbance to players officials or spectators
 - (c) offensive or inappropriate banners, slogans, or emblems, whether written in English or in a foreign language.
 - (d) subject to paragraph (c) flags, banners, emblems or slogans over 1.8 metres in length x 0.9 metres in width.
 - (e) any item that is deemed by the Club, Ground Marshalls, the appointed Security Provider and/or FV as potentially causing injury or a public nuisance or offence to any other user of the venue.
- **7)** Patrons should note that children must always be supervised by an accompanying adult while in the Club Venue.
- 8) Some areas of the venue may be exposed to direct sunlight and heat. Patrons are required to take appropriate care of their sun protection and hydration.



- 9) Smoking is only permitted in designated areas of the venue. For assistance in locating these designated areas, please ask a member of the Club Committee or Ground Marshall.
- **10)** No served alcohol can be taken away from any Club Venue.
- 11) Patrons must cooperate fully with all instructions issued by Victoria Police, venue security personnel, Club staff or FV staff, and must provide accurate identification information to such persons if requested. Any identification details acquired may be provided to FV who may transfer the information to the responsible authorities (eg Victoria Police, FFA, and any other stakeholder at FV's absolute discretion). By entering the venue, a patron shall be deemed to have given consent to the transfer of identification information in accordance with this clause.
- **12)** Any bans issued by any Club and/or FV, will be honoured and enforced by FV and all FV Clubs, and information received will be forwarded to Victoria Police. This information will also be provided to FFA and other stakeholders who may at their discretion also enforce these bans.
- **13)** Any patron who breaches these conditions may be evicted from the venue and may be banned from attending future matches of the Club and all other FV Clubs as determined in accordance with FV policy.
- **14)** In addition, in caring for patron safety the Club and/or FV reserve the right to refuse entry to any person at their absolute discretion.

By entering this venue, or attending this event, you agree and are deemed to be bound by the terms of these Conditions of Entry, the FV GDT, and FV's Member Protection Rules and Policies.

Any patron who breaches these conditions may be asked to leave the venue and may be banned from attending future matches of the Club in accordance with club policy.

All patrons must adhere to the "Spectator & Parents Code of Conduct" at all times.
